Item 1:

Call to Order

Water System Report

City Manager Robyn Smith reported that Dean Woodall wants to set meter on Land Rd because of DOT permit. The council had already made the decision that we will not set a meter except on the front of property.

City Manager handed out monthly financial reports and Council was pleased with the reports.

Overlapping Water Service Area

a) Reported that he had done a follow up email to Bobby Dyer about the overlapping water service area, and hasn't received a response

Service Delivery Strategy Agreement

a) He also reported that the County declined to accept the Resolution 2020-02, so that is not in effect.

Smith, Welch, Webb and White

- a) This could be more of an issue depending on this firm's level of involvement.
- b) May 6, 2019, Waleska hired this firm as Special Counsel for Waleska in connection with matters, including, but not limited it, review, preparation, negotiation and litigation of the SDS, and other related matters.
- c) Fee Agreement City agreed to pay Special Counsel \$500 flat fee. However, the same Agreement states that "City agrees to compensate Special Counsel for services rendered (including expenses) as of the date of discharge by the paying the fair and reasonable value of such services and expenses in accordance with the City's per capita allocation. The City reserves the absolute right to discharge Special Counsel at any time. The City must provide Special Counsel with a written explanation itemizing all reasons for the discharge.
- d) Resolution 2019-09 (Section 3 Representation of the City to Special Counsel) "The City represents that it will pay legal fees, expert witness fees, and all of the cost of preparation, negotiation and litigation incurred by Special Counsel in accordance with the signed fee agreement.

HighPointe Subdivision

a) No update or known issues. Lamar Rogers reported that the only movement is moving dirt and it will probably be April before they need water.

Subdivision Water Service Request
