Item 1: Call to Order

Item 3: Consideration to Approve October 23, 2017 Council Meeting Minutes

Item 4: Consideration to Approve the Rezoning Application for 423 Bartow St to rezone property from R-30 to NC. A total of 3.15 +/- acres is sought to be rezoned.
